Nomad Building Solutions Limited (ASX Code: NOD) (**Company**) advises that that it today issued 3,308,088 fully paid ordinary shares to FTI Consulting (Australia) Pty Ltd (**FTI**) under the terms of a consultancy agreement between the Company and FTI.

The shares were issued in lieu of fees payable by the Company to FTI for consultancy services provided. Each share was issued at a deemed issue price of approximately \$0.0488, being a 10% premium to the 5 day volume weighted average price of the Company's shares.
